The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

The defendant was observed by CPL T. Sims to be driving his white 2007 Chevy SUV (FLTAG #672PCE) southbound on I-275. While driving, it had difficulty maintaining it's lane of traffic by drifting & swerving in and out (over the lane divider lines) on both sides multiple times and jerking back into it's lane. During a traffic stop to check on the defendant's welfare due to the suspicious driving patterns, the defendant was identified via a FL DL and exhibited several clues of impairment; to include: Watery/bloodshot eyes, blank/dazed stare, lethargic appearance, poor balance, slow & deliberate movements, and exhibited a distinct odor of an alcoholic beverage from his breath. He was arrested following a poor performance on SFSEs. While at CBT, the defendant stated that he did not want to provide a breath sample. I read him Implied Consent, and he still refused to provide the sample. He has a prior refusal to submit to a breath test on 06/26/2018.
