at approximately 12:48 AM, at BECKETT LAKE DR/ SUNSET POINT RD, in Pinellas County did:

REASON FOR STOP: JAMES QUATTLEBAUM WAS TRAVELING WEST BOUND ON SUNSET POINT RD AND BECKETT LAKE DR AT A SPEED OF 30 MPH IN THE MEDIAN LANE IN AN AREA POSTED AT 40 MPH HIS VEHICLE WAS DRIFTING WITHIN THE LANE OF TRAVEL. 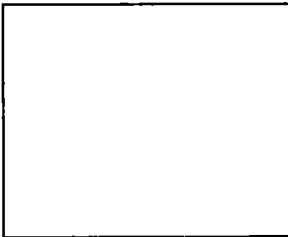
