PROBABLE CAUSE AFFIDAVIT

Before me this date personally appeared **Detective Melvin L. Hancock Jr.** who being first duly sworn deposes and says that on the **29th** day of **March, 2015** at **3001 Holiday Drive, Fort Lauderdale, FL** (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe same are as follows:

The victim is a limousine driver for Larry's Limos. The victim was dispatched to the Bahia Cabana Resort on 03/29/15 at approximately 1:50 AM to pick up one female passenger and transport her to Pembroke Pines. Upon arrival the female fare was accompanied by three additional females and one male who also wanted transportation. The victim was unable to provide this transportation to all of the persons due to conflicts of the previously scheduled transportation needs of other client destinations.

The group seeking transportation was advised by the victim he would be unable to drive all of them to their locations as this was not what had been scheduled with his company. The defendant then became argumentative and angry towards the victim demanding all to be transported. The victim stated to the defendant his company was prohibiting him for any other travel routes. The defendant began react violently towards the victim, shoving the victim rearward, punching him in the face and knocking him to the ground. As a result the victim fell to the pavement unconscious suffering multiple facial fractures which required surgery to repair in the days immediately following the incident. The victim reports he has been advised by his doctors he has also suffered permanent nerve damage to his face as a result of the defendant's attack.

The victim called 911 for police assistance and reported the crime as well as the license plate number of the vehicle in which the suspect had left the area with the four females. The victim was initially treated at Broward County Hospital Emergency Room for the resulting injuries he received. The victim was able to positively identify the suspect through means of a photo line-up presentation during this investigation and desires prosecution in this matter. The victim has also forwarded a sworn statement supporting his report. Today, the suspect was arrested by this detective, charged with felony battery and was remanded to the FLPD jail.

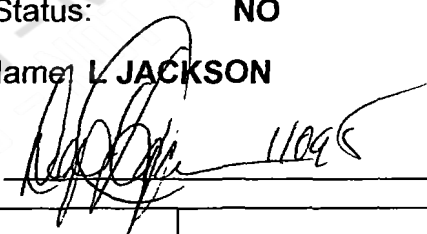

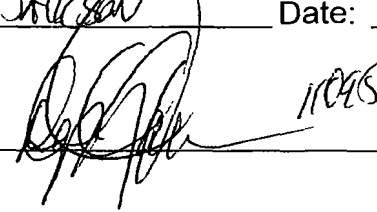
