The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 06/11/2021, at approximately 2329 hours, near the intersection of Big Bend Road and I-75 North, Riverview, Florida 33579 Deputy B. Dobson ABN: 4809 observed the defendant operating a 2007 Silver Ford F-150 bearing Florida tag LSQD25 with an assigned VIN of 1FTRW14WX7FA43052. Upon Deputy Dobson's contact with the defendant, he observed multiple indicators of impairment. While speaking with the defendant, I observed several indicators of impairment. After the defendant exited the vehicle, I observed him to have a strong odor of an alcoholic beverage emitting from his breath, he had slurred speech, and he was unsteady on his feet. The defendant refused to participate in field sobriety exercises. The defendant was arrested for DUI and he provided two lawful breath samples at Central Breath Testing of .150 and .142. The defendant identified himself verbally. I further identified the defendant via his DAVID photograph.
