The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 On the listed offense date, time, and location, an anonymous caller contacted the HCSO Communications Center and advised of a dark gray Jeep bearing Tag #V3647U swerving all over the roadway while traveling northbound on the Veteran's Expressway. At the exit ramp to Gunn Hw, Deputy R. Clark (ABN #4035) observed a 2020 Gray Jeep Cherokee bearing Utah Tag #V364ZB at the light next to him. The vehicle failed to move upon the light changing to green for a cycle. Deputy Clark pulled along the vehicle and the Jeep finally traveled through. The vehicle was then stopped in the middle of the roadway for no apparent reason. A traffic stop was executed by Deputy Clark. During contact, indicators of impairment were detected and a DUI unit was requested. Your affiant responded to the scene and made contact with the driver/defendant (James Gream). Your affiant requested the defendant exit the vehicle to which he complied with. Upon relocating to a nearby parking lot, your affiant also began to detect indicators of impairment such as the odor of an alcoholic beverage emanating from the defendant's breath, his eyes were bloodshot and watery, his speech was slurred, and he was unsteady on his feet. Your affiant requested the defendant perform Standardized Field Sobriety Exercises (SFSE) to which he consented to and performed. During the SFSE, the defendant displayed multiple additional indicators of impairment. Post-Miranda, the defendant admitted to consuming beer and vodka prior to operating his rental vehicle, and confirmed he felt the effects of the alcohol. The defendant was arrested on scene and transported to Central Breath Testing. The defendant refused to provide a breath sample after being read his Implied Consent warnings. The defendant was positively identified via California Driver License and verified he resides in the State of California.
