The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: 09-18-2020 at 03:57, the defendant was observed sleeping in the driver side seat of his 2016 Black Cadillac XTS, bearing Florida tag IN68PJ, while stopped at the traffic light and impeding traffic at the intersection of Busch Blv. E and 26th ST N. The vehicle was on and the gear shift in drive while the defendant's foot was observed on the brake pedal. Upon awakening the defendant and speaking with him a strong odor of an alcoholic beverage coming from his breath was detected. Furthermore, his speech was slurred and his eye were red and glossy and his stance was unbalanced as he swayed side to side once he was out of his vehicle.
