On February 14, 2021 I was on routine patrol in my marked patrol car in Palm Beach County. I responded to the report of a wrong way driver that was traveling southbound on I-95 (State Road 9) from Indiantown road in the northbound lanes.

There were multiple witnesses calling in and advising of the wrong way driver. The vehicle was described as a white BMW SUV traveling in the center lane. The last position update was for southbound at 45th st. I was traveling northbound at Palm Beach Lakes Blvd and observed a white SUV traveling the wrong way in the center left lane. I had my emergency lights and sirens activated and moved to the center right lane to avoid colliding with the vehicle. The vehicle continued southbound on I-95 and I then proceeded to go southbound in the northbound lanes to stop the driver. I then proceeded directly behind the vehicle and it failed to slow down or stop. I then proceeded to move my vehicle to a position to complete a Precision Immobilization Technique (PIT) on the vehicle. Sgt. M. Thomas was aware and authorized the PIT. I then placed the front right bumper on the rear left panel of the vehicle. I then completed the PIT and the vehicle stopped. I observed through the window that a female was in the driver seat and behind the vehicle. I then approached the driver's side of the vehicle and attempted to remove the driver from the vehicle. The driver had difficulty putting the vehicle into park and had to be told multiple times to exit the vehicle. I immediately observed the odor of an unknown alcoholic beverage emitting from her breath as she talked. I also observed that she had bloodshot glassy eyes and thick slurred speech. The driver then exited the vehicle and walked to the left shoulder of the roadway. As the driver walked on the shoulder, I observed that she had an unsteady gait and had to be told multiple times to sit down. I then had the driver stand in the front of my patrol car. As she stood there, I observed that she had bloodshot glassy eyes, thick slurred speech and the odor of an unknown alcoholic beverage was emitting from her breath as she talked. I also observed that she had an orbital sway. I then requested that the driver conduct field sobriety exercises and she refused. Taylor warning was stated to the driver and she stated that she understood and refused again. She was then placed under arrest for DUI and searched and secured inside of my patrol car. Once I arrived at the testing facility, I conducted a 20- minute observation. At no time did she regurgitate or take anything by mouth. I the requested that she provides a lawful sample of her breath and she refused. Implied consent was read, and she stated that she understood and refused again. The driver was later identified as Janemeri Paz by her FL DL.

She was then booked into the county jail. The above incident occurred in Palm



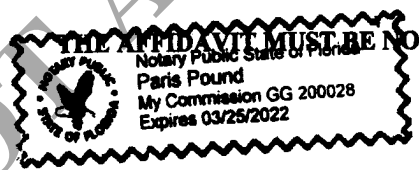
