

The caller, Ronald Peasley, advised BRPD dispatch that her ex-girlfriend, Janet Cordts, was driving in the area while under the influence of alcohol. Peasley described Cordts' vehicle as a navy-blue Ford F-150 bearing a Michigan license plate. According to Peasley, Cordts consumed two "doubles" and her 12-year-old grandson was in the vehicle with her. Cordts' vehicle was last seen in the area of SW 9th St and W Camino Real.</p> <p>Officer Vrabel was the first officer on scene and located the vehicle, a navy-blue 2008 Ford F-150 bearing FL tag BKQ315, stationary at a stop sign at the intersection of SW 9th St and W Camino Real. Officer Vrabel informed me that she approached the vehicle from the driver's side and conducted a consensual encounter with Cordts who was sitting behind the wheel of the vehicle (identified by MI DL). Officer Vrabel also observed that Cordts' 12-year-old grandson, Adam Fredrick, was sitting in the back seat.</p> <p>I arrived a short time later and also observed Cordts sitting behind the wheel of the vehicle with Fredrick in the back seat. I immediately observed that Cordts' eyes were red and glassy, her speech was slurred, and her movements were slowed. I also observed a strong odor of alcoholic beverage emanating from Cordts breath when she spoke.</p> <p>While speaking with Cordts, she spontaneously uttered that she had been drinking and should not have been driving. I asked Cordts what she was drinking, and she advised she consumed two coconut rums at a "club". Cordts did not know what city she was currently in, what street she was driving on, or how to get to her residence in Hillsboro Beach.</p> <p>I asked Cordts to submit to standardized field Sobriety Exercises and she agreed to participate. Initially, Cordts claimed she was not sick or injured, and felt comfortable walking barefoot. Cordts later claimed that she limped due to an old back injury. She</p>

<p>stated she was not diabetic or epileptic and did not have anything wrong with her eyes that is not corrected by glasses or contacts. I then proceeded with the exercises.</p> <p>The first exercise was Horizontal Gaze Nystagmus. I administered the instructions and Cordts stated that she understood. Cordts swayed in a circular motion during the exercise, and I could still smell the odor of alcohol emanating from her facial area. She also needed to be reminded to not move her head during the exercise.</p> <p>The second exercise was the Walk and Turn. While administering the instructions, Cordts stated that she could not perform the exercise due to her level of impairment. I advised Cordts of her Taylor Warnings and she advised she understood and would continue with the exercises. I then finished administering the instructions and demonstrated how the exercise should be completed. Cordts stated that she understood. Cordts broke the starting position during the instruction phase and began the exercise before being instructed to do so. Once told to begin, Cordts missed heel to toe on every step, took the wrong number of steps, made an improper turn, and used her arms for balance.</p> <p>The third exercise was the One-Leg Stand. I administered the instructions and demonstrated how it should be completed. Cordts stated she understood. Cordts began crying and ultimately chose to cease the exercises at this time.</p> <p>Based on the totality of the circumstances, I found probable cause to believe that, at the time of our encounter, Cordts was in actual physical control of a motor vehicle within the state while under the influence alcohol or controlled chemical substances. Cordts was placed under arrest for DUI per F.S.S 316.193(1a).</p> <p>Cordts was transported to Palm Beach County Sheriff's Office DUI Testing Facility where PBSO Breath Operator Ragin (#16877) conducted the BAT room procedures. Cordts was asked to provide a breath sample for the purpose of determining its alcohol content and she refused to submit. She was informed of implied consent and stated she understood. Cordts continued to refuse to provide a breath sample. She was informed of her constitutional warnings (Miranda) and stated she understood. Cordts refused to answer any further questions without an attorney present. See DUI influence report for further.</p> <p>Cordts was then turned over to PBSO at Palm Beach County Jail.</p>
