On the 24 day of January, 2020 at 15:49 (Specifically include facts constituting cause for arrest.)

I responded to a call from Neiman Marcus security, located at 151 Worth Ave. advising of a theft in progress. Neiman Marcus Security personnel confronted the suspect prior to officer's arrival and had the suspect detained in their security office.

Upon officers arrival the suspect identified via United Kingdom DL as Janos Buda, W/M, DOB 07/17/1971, kept saying "I'm sorry". At approximately 2:30pm, Neiman Marcus Security personnel observed via surveillance cameras, Buda walking around the fragrance department, pick up a men's fragrance tester and conceal it in a shopping bag he was holding. He then walked over to another display, picked up a sealed box of "Tom Ford" men's fragrance and drop it into the green "Trillion Palm Beach" shopping bag. Buda was then confronted by security. Inside the bag was merchandise security recognized as being theirs.



Steven Radentz, Neiman Marcus Security, provided PBPD with a copy of the video surveillance and merchandise SKU information to include prices for the following items retrieved from inside the green bag:

- Tom Ford "Oud Wood Decanter" 8.5 oz fragrance (value: \$615.00)
- "7 For All Mankind" denim slacks (value: \$189.00)
- "7 For All Mankind" denim jeans (value: \$210.00)
- "Stefano Ricci" formal shirt (value: \$1,200.00)
- "Tom Ford Patchouli" tester (no value).

The total amount of merchandise is \$2,214.00.

Radentz completed an affidavit of prosecution indicating they would prosecute for the theft of merchandise. Post Miranda Warning, which was read from a pre-printed Miranda Warning Card, Buda stated he was very sorry for taking the items. He stated he dropped the items in the bag. He also stated he asked Neiman Marcus employees if he could pay for the items after he got caught. He stated he had money in his wallet to pay for the items, but he wasn't going to pay for them.

Based on the investigation, probable cause exists to arrest and charge W/M Janos Buda with Grand Theft, pursuant F.S.S. 812.014(2)(C)(1) for the theft of merchandise.
