The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 07/02/2021 at approximately 1529hrs, affiant conducted a vessel stop on a 21' white center console Maverick boat bearing FL2338RW / Hin: CBACX106D919 within 1 Seddon Channel Tampa, Hillsborough County, FL 33606 for the purpose of a vessel safety inspection. Upon stopping the vessel, affiant made contact with the operator / defendant, who was standing at the helm of the vessel. During personal contact with the defendant, affiant observed him to have blood shot watery eyes and detected a strong odor of an alcoholic beverage coming from his person(s). Based on this, affiant requested the defendant perform seated sobriety tasks to determine if he was operating a vessel while under the influence of an alcoholic beverage and/or controlled/illegal substance. The defendant agreed to the SFSTs. Based on observations of impairment, the defendant was arrested for boating under the influence and secured in handcuffs (1550hrs). The defendant was advised of Florida Implied Consent (1551hrs). The defendant stated he understood and refused to provide a breath sample. The defendant verbally identified himself and was identified by Kansas driver license.
