The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: The defendant was driving a white 2015 Maserati bearing a Florida license plate of PKQL66. He was traveling east on the Courtney Campbell Causeway just west of Bayport Dr and was traveling at a high rate of speed, estimated speed was 90 MPH. I activated my certified and calibrated laser and obtained a speed reading of 91 MPH in this posted 50 MPH zone. A traffic stop was made and upon making contact with the defendant he displayed multiple indicators of impairment, to include; watery and bloodshot eyes, slurred speech, a strong odor of an alcoholic beverage, and an admission to consuming alcohol. The defendant performed SFSEs and multiple clues of impairment were observed. The defendant was arrested for DUI and later refused to submit to a breath test despite acknowledgment of the Implied Consent Warning. The defendant was identified by his FL DL.
