The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On the above listed date, time, and location I responded to assist Dep. Gibb (ABN:257675) with a Suspicious Vehicle call for service. Dep. Gibb was traveling west on Delamere Ct. when he observed a tan 2006 Jeep Wrangler bearing FL tag #PDCB86 (VIN:1J4FA39S26P734601) stationary at the intersection of Swift Cr. Dep. Gibb observed the vehicle running with the defendant unresponsive in the driver seat holding the gear shifter. This vehicle was in neutral, with the keys in the ignition. Dep. Gibb woke the driver and observed indicators of impairment. Dep. Gibb observed glossy eyes, lethargic behavior, unsteady on his feet, and slurred speech. I arrived on scene and observed the defendant standing with Dep. Gibb. I made contact with the defendant and observed indicators of impairment to include glossy eyes, slurred speech, unsteady on his feet, and lethargic behavior. Post Miranda, the defendant admitted to consuming marijuana earlier in the night. The defendant was asked to participate in the Standardized Field Sobriety Exercises, which he agreed. During the exercises the defendant showed signs of impairment. The defendant was subsequently arrested for DUI. The defendant provided a lawful sample of breath (BAC .000/.000). The indicators of impairment observed did not match the BAC level provided. The defendant was asked to provide a urine sample, he agreed. Positively identified via DAVID photo.
