The following incident occurred in the City of Delray Beach, County of Palm Beach, Florida.

OFFICER'S NARRATIVE:
 On 05/23/2020, at approximately 1838 hours, I responded to 3025 S Federal Hwy regarding a burglary to vehicle in progress. Upon officers' arrival, we were informed by witness, Scott Tarique, that the suspects, two Hispanic females wearing white shirts, had fled the area in a silver Hyundai northbound on S Federal Hwy. Tarique also provided me with a driver's license and misc. papers of one of the suspects that had fallen onto the ground and he recovered. The driver's license belonged to Rosie Gutierrez. Officers quickly searched the area and K9 Officer Mintus was able to locate and stop the vehicle, a silver Hyundai Elantra bearing FL tag LMAI87, at 300 W Linton Blvd. He then made contact with the driver, Jasmine Anleu and passenger, Rosie Gutierrez. Sgt. Grammatico responded as a back-up officer to the traffic stop and both he and K9 Ofc. Mintus questioned both suspects regarding the vehicle burglary. They noticed the driver was showing signs of impairments and they contacted me to conduct a DUI investigation.
 Upon my arrival, I made contact with Sgt. Grammatico and K9 Ofc. Mintus. They advised me of their observations (see their supplements for further). I then made contact with driver, Jasmine Anleu, who was sitting down on the curb. I asked her to stand up and walk towards my marked patrol vehicle #1732. I then proceeded to ask her non-incriminatory questions (pronunciation of name, where she is from). It should be noted that Anleu was extremely upset and crying. While speaking with her, I had to remind her several times to take deep breaths to calm down her crying. It should be noted that as she exhaled from each of these breaths, I could smell the odor of an unknown alcoholic beverage on her breath. Her eyes were glossy and red. I then advised her that I was present to conduct a DUI investigation. I requested for Anleu to submit to the Standardized Field Sobriety Tasks and she agreed. I then administered the
