The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 12/20/2019 at 0222 hours, concerned that the driver was either ill, fatigued, or impaired, I conducted a traffic stop at 4202 Kennedy Bl W on a gray 2015 Kia Optima sedan, FL tag DAKM93 after I observed that the vehicle was drifting from side to side as it traveled west bound on Kennedy Bl W from Dale Mabry Hw S. Upon contact with the driver of the vehicle, defendant Jason Mersch, I observed that he had bloodshot glassy eyes. Then as I explained to him why I had stopped him I detected a distinct odor of an alcoholic beverage. The defendant then exhibited additional signs of impairment during the SFSEs. At which time I placed him under arrest for DUI based upon all of my observations made thus far in my investigation. The time of arrest was 0234 hours. I then transported the defendant to the HCSO/CBT Facility where he submitted to a breath test. His BAC was .058/.062. I identified the defendant with a valid FL DL.
