The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did The victim and defendant became engaged in a verbal argument. The defendant intentionally, and without the permission of the victim, placed his hands around the victim's neck in an apparent attempt to strangle her. The victim's normal breathing was impeded, and the victim suffered ringing in her ears and a nose bleed. The defendant also shoved the victim against a wall, possibly causing additional bleeding from her nose.

During the arrest, the defendant actively resisted by tensing and bracing. Verbal commands were given by fully uniformed police officers and a ECD was ultimately deployed to gain compliance. Following the first ECD activation, the probes became dislodged and a drive stun was used to gain compliance. The defendant attempted to grab the ECD from the affiant two times, during the attempted arrest.

The victim and defendant have a child in common and reside together as a family.

The defendant ID himself verbally (photo confirmed). The victim also ID the defendant on scene.
