The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On the above listed date and time, at the above listed location, I observed a black, 2013, Ford F150 pickup (FL Tag: DV2139P/VIN: 1FTFW1CT5DFA04004) traveling westbound on Causeway BL. I observed the vehicle swerving, driving over the dashed lane marker, and changing lanes abruptly without signaling the vehicle intentions. Based on the erratic driving pattern, I believed the driver was ill, tired, or impaired, and I conducted a traffic stop. Upon making contact with the defendant and sole occupant of the vehicle, I immediately observed multiple signs of impairment. Affiant requested the defendant to perform Standardized Field Sobriety Exercises (SFSE), which the defendant agreed to perform. During the exercises the defendant showed multiple signs of impairment and was subsequently arrested for DUI. The defendant refused to provide two lawful breath samples to determine his breath alcohol content (BrAC). I read Implied Consent to the defendant in room #1 of Central Breath Testing. The defendant verbally acknowledged he understood the Implied Consent, however he still refused. The defendant received a DUI citation #A30N7AE, which reflects the DUI charge. The defendant was identified via his Florida driver's license.
