The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 10/23/2020, at approximately 0313 hours, the defendant and the victim were engaged in a verbal argument in the bathroom at 11537 Misty Isle Ln. The incident became physical when the defendant knowingly and intentionally struck the victim's chest area with his chest as he used both of his arms to wrap around the victim's waist and tackle her, which was against the victim's will.

As a result of the physical altercation, the defendant sustained an approximate half inch cut to the top right side of his forehead (along the hairline), which he received from striking the bathroom's toilet paper holder. The victim did not sustain any injuries. Both, the victim and defendant, refused EMT and any medical attention.

The defendant and the victim, live together as a family, have been married for approximately three (3) years and have one minor child in common.

The victim positively identified the defendant verbally as the person who committed the offense. The defendant's identity himself verbally, which was also confirmed via his Washington Driver's License. The defendant does not qualify for the Adult Pre-Arrest Diversion (APAD) program because of the domestic nature of the incident and because he did not admit to the offense.
