The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did The defendant was driving a blue 2012 Honda Civic bearing a Florida license plate of LMXG56 and traveling south on MacDill near W Neptune St. The defendant was paced traveling at 50 MPH in a 35 MPH zone for several block. The vehicle also had inconsistent speeds. He slowed down and sped up for no apparent reason. As the vehicle traveled south of Bay to Bay Blvd I paced him at 48-50 MPH in a 35 MPH zone for at least five blocks, and he was weaving back and forth. Upon making contact with the defendant he displayed multiple indicators of impairment, to include; watery and bloodshot eyes, slurred speech, very emotional, an odor of an alcoholic beverage on his breath, and an admission to consuming three beers. Multiple clues of impairment were observed during the SFSEs and he was arrested for DUI. The defendant later made a spontaneous statement that he also consumed a double Tequila shot. The defendant later submitted to a breath test which had a BrAC result of .131 and .131. The defendant was identified by his FL DL.
