Probable Cause

On Tuesday May 26th, 2020 at approximately 7:15 AM, I was called to a traffic stop by Sgt. Kingery who had a vehicle stopped on Florida's Turnpike (SR91) southbound at mile marker 113. I arrived on scene and observed Sgt. Kingery on the stop with a black Chevrolet Tahoe. Sgt. Kingery requested the driver outside of the vehicle and was speaking with the driver. Sgt. Kingery went to his vehicle while I spoke with the driver outside of Sgt. Kingery's passenger door. The driver began speaking with me and stated that he had some stuff in the vehicle and that he met a guy last night that gave him half a Xanax and half an Adderall. The driver who was identified by CT DL as Jason Lee Kauffroath advised me that he had a prescription for Suboxone but he did not have any and he took his girls bottle with her suboxone so it was not his.

A handsearch was conducted and inside of it there was a coffee cup with iced coffee and inside of the cup was a clear ziplock with an unknown substance that the coffee leaked inside of. There was also a clear smoking pipe. Sgt. Kingery utilized his issued Tru-Narc and tested the substance inside of the pipe which came back as Meth and clear rock like substances were located on the driver seat scattered around. The Tru-Narc came back as these substances positive for Meth. Mr. Kauffroath was placed under lawful arrest for possession of Suboxone, Adderall, Xanax, Meth, paraphernalia and giving false ID to LEO, and destruction of evidence due to the fact that it was obvious Mr. Kauffroath attempted to conceal the clear ziplock baggie and clear pipe inside of his coffee cup and attempt to have the substance dissolve. Mr. Kauffroath was transported to PBSO Jail by Tpr. R.


