The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 The defendant was observed in the Ybor Parking Garage located at the above address by two Ybor security guards (witnesses) in actual physical control of a black in color Ford F150 bearing FL tag JSYI60. The defendant was in the driver seat with the vehicle on and operational. The defendant appeared to be passed out at the wheel. The witnesses attempted to make contact with the driver due to the vehicle starting to roll forward and potentially striking pedestrians. The defendant woke up and stepped on the gas nearly striking pedestrians in the garage which forced security to physically enter the vehicle and turn it off.

When they made contact with the defendant, he showed clues of impairment. I made contact with the defendant who was leaning against his vehicle to maintain his balance. He had slurred speech, watery/glassy eyes, and a strong odor of an alcoholic beverage coming from his mouth and person. The defendant was placed under arrest due to showing indicators of impairment during contact. The defendant refused to conduct standardized field sobriety exercises and refused to provide a breath sample at CBT.

The defendant was identified via FL DL.
