

Probable Cause

On April 5, 2022 while on routine patrol in my marked patrol vehicle, I responded to a hit and run accident that occured southbound on Interstate 95 south of Northlake Blvd. The victim was waiting for a report on Southern blvd just East of

195. Upon making contact with the victim, I identified him by his Florida drivers license(W452813003900). The victim stated a physical altercation had taken palce after the accident between himself and the suspect driver. The victim stated that the suspect had grabbed his shirt and pushed him before leaving the scene of the crash. I then observed the victims shirt to ripped and stretched around the collor and for the victim to have a scratch on his neck. During this altercation the victim states that the suspect told him he was a cop. The victim told the suspect he didnt believe him so the suspect went to his car and pulled out his badge to show the vicitm. The victim states that what the suspect showed him did appear to be a badge. The victim was able to show me a video that showed what the suspect driver looked like. A middle aged white male. I completed the crash report to give to the victim and had the victim complete a sworn written statemen. I then continued my investigation by going to the address on the suspect vehicles registration.

Upon arriving at the address, I observed no one to be home at the time. I then made contact with workers outside the house and they advised someone else lives at the home and not the person I was looking for. They called the owner of the home and he advised that he bought the house from Jason Barquin who had the same last name as the registered owner of the suspect vehicle. The owner of the home advised the previous owner, Jason, was a police officer that worked for the west palm beach dept which lead me to believe Jason could be my driver. Sgt Kingery was able to find another address for suspect vehicle using David. I then went to the suspect address.

Upon arriving at the address 3122 SW Lake Terrace was able to make contact with the suspect driver who I identified to be Jason Barquin by his Florida drivers license(B625436833330). Jason advised he was infact driving the vehicle when the crash occured and he did have an altercation with the victim. I then advised Jason the facts of the crash and gave him the drivers exchange. I then advised jason I was changing hats from a crash investigation to a criminal investigation. I read Jason his Miranda Warnings and Jason agreed to answer questions. Upon questioning Jason, Jason advised he did grab the vicitm by his shirt and push him

but only because the victim got into his face and bumped jason's head with his phone. Jason also advised he did tell the victim he was a police officer or had been previously and he admitted to showing the victim his West Palm Beach Police Department badge to which he is no longer employed. Jason also admitted to leaving the scene of a crash but only because he belived there was no damage. Jason's statements were audioly recorded.

Based off the above statements given by both parties, Jason was placed under arrest for Florida Statutes 784.03.1a1, 843.085.1, 843.08 and 316.061 at 2:13 p.m.

All above events occured in Palm Beach County.
