The undersigned swears that he/she has reasonable grounds to believe that the above named defendant on the 12 day of JANUARY, 2020,

at approximately 3:37 AM, at 3088 POINTER DR, in Pinellas County did:

ACTUALLY AND INTENTIONALLY TOUCH OR STRIKE JAMIE VREELAND, HIS GIRLFRIEND AND CO-HABITANT, AGAINST THE WILL OF JAMIE VREELAND, TO-WIT: PUNCHED MULTIPLE TIMES CAUSING A BLOODY NOSE AND SWELLING.

VICTIM STATED SHE HAD BEEN AT AN AWARDS BANQUET WITHOUT HER BOYFRIEND. VICTIM SAID THAT SHE HAD BEEN DRINKING SO TOOK AN UBER HOME. VICTIM STATED THAT THE DEFENDANT, HER BOYFRIEND, BECAME INCREASINGLY ANGRY AND ACCUSED HER OF BEING OUT WITH ANOTHER MAN. VICTIM WENT TO BED AND WAS AWAKENED BY THE DEFENDANT YANKING HER OUT OF BED AND STRIKING HER IN THE FACE. A STRUGGLE ENSUED DURING WHICH THE VICTIM WAS STRUCK IN THE FACE 2-3 TIMES CAUSING A BLOODY NOSE AND SWELLING. VICTIM STATED THE ATTACK FRIGHTENED HER TO THE EXTENT THAT SHE URINATED HERSELF WHILE ON THE FLOOR. FOLLOW UP AT THE SCENE DID SHOW A WET SPOT WHERE THE VICTIM INDICATED SHE WET HERSELF DURING THE OFFENSE.

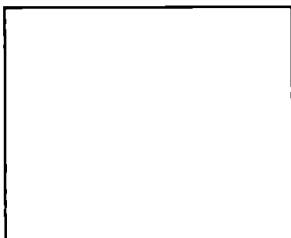
