The undersigned swears that he/she has reasonable grounds to believe that the above named defendant on the 15 day of MARCH, 2020, at approximately 11:00 PM, at 2525 WEST BAY DR APT B42, BELLEAIR BLUFFS, FL 3377, in Pinellas County did:

ACTUALLY AND INTENTIONALLY TOUCH OR STRIKE VICTIM, HIS GIRLFRIEND AND CO-HABITANT, AGAINST THE WILL OF VICTIM, TO-WIT: FORCEFULLY GRAB VICTIM'S RIGHT LEG AND ATTEMPT TO PULL THE VICTIM OFF OF A COUCH.

ON SAID DATE AND TIME, I RESPONDED TO SAID ADDRESS, IN REFERENCE TO A CONTACT CALL FOR SERVICE. THE VICTIM'S FATHER CONTACTED P.C.S.O. ADVISING THAT THE VICTIM INFORMED HIM THE SHE WAS INVOLVED IN A PHYSICAL ALTERCATION WITH THE DEFENDANT. UPON ARRIVAL ON SCENE, CONTACT WAS MADE WITH THE VICTIM WHO STATED THE SHE AND THE DEFENDANT ENGAGED IN AN ALTERCATION EARLIER IN THE EVENING. THE VICTIM ADVISED THAT THE ALTERCATION BEGAN VERBALLY, BUT ESCALATED TO A PHYSICAL ALTERCATION WHEN THE DEFENDANT FORCEFULLY GRABBED THE VICTIM'S RIGHT LEG, SQUEEZED TIGHTLY CAUSING PAIN, AND ATTEMPTED TO FORCEFULLY PULL THE VICTIM OFF OF THE COUCH SHE WAS SITTING ON. THE VICTIM ADVISED THAT WHEN THE DEFENDANT GRABBED HER RIGHT LEG, SHE YELLED "YOU'RE HURTING ME" AND "GET THE FUCK OFF OF ME", HOWEVER, THE DEFENDANT DID NOT RELEASE HER. THE VICTIM STATED THAT SHE USED HER LEFT LEG TO KICK THE DEFENDANT'S CHEST, DUE TO FEAR THAT THE DEFENDANT WOULD CAUSE HER FURTHER PHYSICAL HARM IF HE DID NOT RELEASE HER. THE VICTIM ADVISED THAT SHE TOLD THE DEFENDANT THAT SHE WILL CONTACT LAW ENFORCEMENT, WHEN THE DEFENDANT FLED THE APARTMENT ON FOOT IN AN UNKNOWN DIRECTION. IT SHOULD BE NOTED THAT THE VICTIM STATED THAT THE DEFENDANT HAD BEEN CONSUMING ALCOHOLIC BEVERAGES PRIOR TO THE BATTERY, AND THAT HE OFTEN BECOMES VIOLENT WHEN INTOXICATED. THE VICTIM REFUSED TO PROVIDE THE DEFENDANT'S INFORMATION DUE TO FEAR OF RETALIATION, HOWEVER, THE DEFENDANT'S INFORMATION WAS PROVIDED BY THE VICTIM'S FATHER. THE VICTIM AND DEFENDANT RESIDE TOGETHER AND HAVE A CHILD TOGETHER.

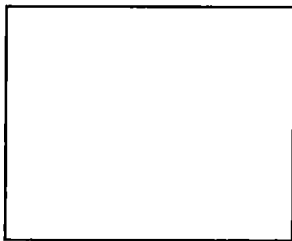
