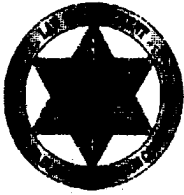

VI. Details of BUI

A. Initial Observations

On March 14, 2021 at approximately 7:46PM I Officer George Spirito along with Officer Casey Schroer and Officer Adam Boyd of the Florida Fish and Wildlife Conservation Commission (FWC) were on patrol in a marked patrol vessel in the area of the Jupiter Inlet.

We observed a Jet Ski violating the slow speed zone located at the Jupiter Triangle area of the Intracoastal Waterway.

B. First encounter

We conducted a stop of the Jet Ski FL 1897SR just outside of the Jupiter Inlet. Due to the sea conditions we followed the Jet Ski to back to the slow speed area of the Jupiter Triangle. At this time, I observed that the operator later identified as Jasper Walsh had bloodshot eyes and an odor of an alcoholic beverage emanating from his person. I asked Walsh what he had to drink on this date, and he stated nothing. After further questioning he stated that he had 4 beers. Walsh had slurred speech and at times he was difficult to understand. At this time, I assisted Walsh to my vessel to preform Field Sobriety Tasks.

C. Completion of Standardized Field Sobriety Tasks

I asked Walsh to perform some sobriety tasks and he agreed. I asked him if he had any medical conditions and he stated that he did not.

Horizontal Gaze Nystagmus

The first task that I administered to Walsh was the horizontal gaze nystagmus. I explained the instructions to Walsh. I had to reminding him to only move his eyes and not his head. Walsh had lack of smooth pursuit in both eyes, nystagmus and maximum deviation in both eyes and nystagmus prior to 45 degrees in both eyes.

Finger to Nose

Walsh had to be told several times to not start the test before I told him too. He was unable to touch the pad of his finger to his nose and had to be reminded to return to the starting position several times.

Palm Pat

Walsh was unable to follow instructions and started at the wrong time. Walsh rolled his hands and had to be reminded to speed up several times.

Hand coordination

Walsh was unable to follow instructions and did not stay in the instructional phase. After the first stage of the test Walshe went to clap and finish the task without counting back to his chest. Walsh did not finish in the End Position.

D. Arrest

At this time based on my interaction with Walsh and my observations of the tasks that he attempted. I placed Walsh under arrest for operating a vessel under the influence of alcohol. Walsh was Handcuffed and his handcuffs were double locked.

Walsh's vessel was escorted to the dock at Jonathans Landing.

Walsh was transported in my marked patrol vehicle by myself and Officer Schroer from Jonathans Landing to
