The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 On 09/13/2020, at approximately 0338 hours, I arrived at E Fletcher and N56th St as a backup officer (see Sgt Lebovitz supplement for additional information). I observed a silver in color vehicle pulled over and made contacting the DEF/driver (Jaxon Christianopoulos). I could smell the odor of an alcoholic beverage emanating from Christianopoulos' exhaled breath. Christianopoulos also had bloodshot and glassy eyes and advised he was at the house and he stated that, "he had 3 beers about a week ago". Upon talking with Christianopoulos, he had slowed speech.

I asked Christianopoulos if he would complete SFSE's to which he responded, "yes". Christianopoulos performed HGN, walk and turn, one leg stand, and finger to nose exercise under my direction. Due to the results of the exercises, I placed Christianopoulos under arrest and transported him to Central Breath Testing. At Central Breath Testing he was turned over to operator C. Holland, who conducted breath test, results as follows; .195 and a .214.
