The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On the listed offense date, time, and location, your affiant conducted a traffic stop on a 2011 Porsche SUV bearing Florida Dealer Tag #PE952J (VIN #WP1AB2A2XBLA54867) for unlawful speed, traveling 66 MPH in a posted 35 MPH zone, captured on your affiant's HCSO issued TruSpeed Laser Device. Upon contact with the defendant (Jay Koker), who was the sole occupant, several immediate indicators of impairment was detected, such as the odor of an alcoholic beverage, his eyes were red and glassy, and he was fumbling with attempting to locate requested documents. Your affiant requested the defendant exit the car to perform Standardized Field Sobriety Exercises (SFSE) to which he complied and consented to. During the exercises, several additional indicators of impairment were observed. Post-Miranda, the defendant admitted to consuming Vodka and Grapefruit juice prior to operating his motor vehicle on the roadway. The defendant was arrested on scene for DUI and transported to CBT, where he refused to provide a breath sample, even after being read his Implied Consent warnings. A DAVID driver history revealed the defendant was adjudicated guilty for DUI once prior on 06/23/2015 (Citation #4077XEG / Polk, FL) with one (1) prior suspension for Refusal to Submit to Breath/Urine/Blood Test. The defendant was positively identified via Florida Driver License.
