The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 10-10-2021, at 0250 hours, while patrolling the area of Lithia Pinecrest Road / Bloomingdale Avenue, Deputy Castelli #259811 observed a blue Chevrolet Silverado bearing FI temporary tag DAU2533 and VIN 1GCRCPEX9BZ108161, driving erratically and the vehicle eventually struck a curb. Deputy Castelli stopped the vehicle to conduct a welfare check and upon making contact with the driver (defendant), he observed her displaying indicators of impairment.
