The undersigned swears that he/she has reasonable grounds to believe that the above named defendant on the 24 day of NOVEMBER, 2019,

at approximately 4:12 AM, at 2291 EAST BAY DR, in Pinellas County did:

UNLAWFULLY HAVE IN HER ACTUAL OR CONSTRUCTIVE POSSESSION, A SUBSTANCE DEFINED BY FLORIDA STATE STATUTE CHAPTER 893, ALPRAZOLAM 2 MG, SCHEDULE 4 TO WIT: , WITHOUT HAVING LAWFULLY OBTAINED SAID SUBSTANCE FROM A VALID PRACTITIONER. THE SUBSTANCE WAS IDENTIFIED BY DRUGS.COM.

OFFICERS WERE DISPATCHED TO A PHYSICAL FIGHT AT THE SEVEN ELEVEN GAS STATION. PRIOR TO OFFICERS ARRIVAL THE COMPLAINANT GAVE A VEHICLE DESCRIPTION FOR ONE OF THE VEHICLES INVOLVED THAT FLED AND PROVIDED A PARTIAL TAG (MKTK29). A TRAFFIC STOP WAS CONDUCTED AND UPON MAKING CONTACT WITH THE DEF (DRIVER) YOUR AFFIANT DETECTED THE ODOR OF BURNT CANNABIS EMANATING FROM THE VEHICLE. THE DEF ADMITTED TO SMOKING "MARIJUANA" IN HER VEHICLE EARLIER IN THE EVENING AND CONSENTED TO A SEARCH OF HER VEHICLE. AS I OPENED THE DEF'S DRIVERS SIDE DOOR I OBSERVED A SINGLE ALPRAZOLAM TABLET IN THE DRIVERS SIDE DOOR HANDLE POCKET. POST MIRANDA THE DEF DENIED THE SUBSTANCE BELONGED TO HER AND STATED THAT SHE DOES NOT HAVE A VALID PRESCRIPTION FOR THE NARCOTIC. THE OTHER TWO PASSENGERS ALSO DENIED IT BELONGED TO THEM.

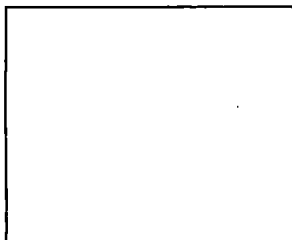
