The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did The defendant was driving a white 2004 Ford F-150 (FL TAG #598QNP) westbound on Platt St W from Westland Av S. This section of Platt St W is a 1-way road with eastbound traffic only, and traffic was heavy at the time (Saturday night in Soho bar district). During the traffic stop for the wrong-way infraction, the defendant was identified via a FL DL and exhibited several clues of impairment, to include: Watery/bloodshot eyes, blank/dazed stare, droopy eyelids, slurred speech, lethargic demeanor, poor balance (swayed heavily when standing still), fumbling fingers, had short-term memory loss (asked the same questions multiple times in a short time period), was wearing a green paper nightclub wristband, and emitted a distinct odor of an alcoholic beverage from his breath. He was arrested for DUI following a poor performance on SFSEs. While at CBT, he provided 2 valid breath samples, measuring .248/.231 BrAC.
