The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did The defendant was driving a 2003 white Acura SUV bearing a North Carolina license plate of CKL4246. He was traveling east on Kennedy Blvd near S Howard Ave and was weaving back and forth, touching and going over the lane dividers, failing to maintain his lane. The defendant also made a wide left turn onto N Boulevard and almost struck the curb. A traffic stop was made and the defendant struck the curb as he was pulling over. He then stopped with the passengers side tires on the curb. Upon making contact with the defendant he displayed multiple indicators of impairment, to include; watery and bloodshot eyes, droopy eyelids, slurred speech, a strong odor of an alcoholic beverage, and an admission to consuming alcohol ("At least four tequila sunrise". The defendant performed SFSEs and multiple clues of impairment were observed. The defendant was arrested for DUI and later submitted to a breath test which had a BrAC result of .211/.198. The defendant was identified by his NC DL.
