The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 01/09/2021, at approximately 0046 hours, I conducted a traffic stop at the intersection of 41 Hw N. and 19th Av NW. on a white in color, Toyota Van(DDBR96/VIN:5TDKZ3DC7HS833369) due to the vehicle traveling seventy miles per hour in a fifty-five miles per hour speed limit zone. When I made contact with the defendant, who was the only person in the vehicle, I observed her to have watery/glassy eyes, slurred speech, and the odor of an alcoholic beverage emitting from her breath. The defendant elected to perform the standardized field sobriety exercises, and doing so, I observed more indicators of impairment. At Central Breath Testing, at Orient Road Jail, the defendant elected to provide lawful samples of her breath after a twenty minute observation. The breath samples were recorded at .158 and .155. The defendant identified herself via Florida driver's license.
