at approximately 8:10 PM, at 82030-4 AVE N, PINELLAS PARK FL 33781, in Pinellas County did:

BY USE OF A DEADLY WEAPON, TO-WIT: A HEINEKEN BEER BOTTLE, DID KNOWINGLY AND INTENTIONALLY CAUSE BODILY HARM TO DORIS PAIGE TOGGER. DEFENDANT IS THE SISTER OF VICTIM'S BOYFRIEND. DEFENDANT CAME TO THE VICTIM'S HOUSE TO CONFRONT VICTIM OVER LONGSTANDING PERSONAL CONFLICT AND DEFENDANT'S PERCEIVED DISMISSIVE ATTITUDE ABOUT COVID19 PRECAUTIONS. DEFENDANT STRUCK VICTIM IN THE FACE WITH THE BEER BOTTLE, CAUSING SIGNIFICANT SWELLING TO HER LEFT FOREHEAD AND EYE AND MINOR CUTS TO VICTIM'S SCALP AND NECK. DEFENDANT CONTINUED TO BATTER VICTIM BY PUSHING HER TORSO WITH OPEN HANDS, PUNCHING HER IN THE HEAD WITH CLOSED FISTS, AND WRESTLING WITH HER UNTIL VICTIM WAS ABLE TO BREAK FREE AND DEFENDANT WAS TOO SPENT TO CONTINUE THE BATTERY.
