Craver #242967, contacted the driver on a traffic stop for driving south while on the northbound lanes of Alexander Street causing him to take evasive action. Upon contact with the driver, the driver emitted an odor of an alcoholic beverage from his breath, he had slurred speech, he had fumbling fingers while retrieving his documents, had bloodshot and watery eyes, and unstable balance. Field sobriety exercises were conducted and impairment was observed. The driver was arrested for DUI and provided two lawful breath samples (.247/.240 BAC).
