The vessel was also stopped for the purposes of conducting a boating safety inspection. Your affiant immediately noticed the odor of an alcoholic beverage coming from the defendants breath, blood shot watery eyes and alcoholic beverages aboard the vessel. Your affiant asked the defendant to conduct SFST's which he agreed to. The defendant showed signs of impairment and was arrested for boating while normal faculties impaired (BUI). The defendant refused to provide a lawful test of his breath for the purpose of determining its alcoholic content.
