NARRATIVE:

On 06/02/2020, at approximately 0930hrs, Oscar Garcia and an unknown male, at the direction of Claudia Perlman DOB: 04/30/1965 (home owner), arrived at 23048 Oxford Place #A, Boca Raton, FL to install a CCTV surveillance system. Garcia's niece, Jemma Perlman DOB: 02/25/1988, and her live in boyfriend, Anthony Demarco (victim), are the current residents.

Demarco has lived with Jemma since December 2019, moved out for a short period of time due to domestic issues and then retook residency approximately three weeks prior to this incident.

Jemma directed Demarco to stay inside their bedroom, with the door locked, because the previous domestic issues were with Perlman's family members not liking Demarco; Specifically Claudia Perlman, who resides out of state.

After installing the surveillance system, Garcia and the unknown male began pounding on Demarco's bedroom door demanding he get out of the residence. Fearing for his safety, Demarco called 911 for Law Enforcement assistance. The suspects ultimately breached the locked door and cornered Demarco, ordering him to leave his residence. The suspects then temporarily left the room, Demarco re-locked the door, only to have Garcia and his associate return, re-breach the door and again corner him. The suspects directed Demarco to leave or they're "going to beat his ass." The unknown male then placed Demarco in a headlock, while both suspects punched him in the face and torso, with closed fists. Demarco frantically tried to call 911. Garcia reacted by

grabbing and removing Demarco's black colored iPhone 11 (305-609-4816) from his hands. The suspects continuously beat Demarco from his upstairs bedroom to the downstairs front door, where they picked up and threw him out onto the patio. Garcia locked the door behind them, ran to his white van and fled the area. The unknown suspect, who now had possession of Demarco's stolen iPhone, travelled on foot towards Boca Rio Rd.

Demarco identified suspect one as Jemma's uncle, Oscar Garcia. Demarco advised Garcia had been released from FL DOC in 2017. Upon conducting a records check, I located Oscar Garcia DOB: 09/26/1966, who had been released from FL DOC in 2017, after serving a ten year sentence. Garcia owns one vehicle, a white 2006 Chevy van bearing FL tag IUH-X40.

I presented Demarco with a FL DOC picture of Oscar Garcia, who he identified as such.

During the incident, neighbor, William Uhl DOB: 10/15/1963, heard Demarco pleading with the suspects to give him his phone back.

Utilizing his iPhone, prior to it being stolen from him by Garcia, Demarco was able to take multiple videos of the suspects breaking into his room, cornering him, verbally assaulting him and the initial battery.

The following day, on 06/03/2020, Demarco used his IWatch to track his stolen iPhone, which he located, hidden under a rock, along Boca Rio Rd. Demarco photographed its location of recovery and then sent me the stated videos.

Between the time his iPhone was stolen and its recovery, Demarco was able to continue communications through the use of his IWatch.

Upon reviewing the said videos I could clearly see Garcia's face and the second suspect's face. These two individuals are seen breaking into Demarco's bedroom, confronting him, cornering him, verbally threatening/assaulting him and battering him. Suspect two is wearing a gray colored hat turned backwards, a green bass pro shop shirt, black shorts and sandals. He appears to be approximately 5'8"/250lbs, with a full beard.

Demarco sustained injuries/abrasions/bruising to his legs, torso and face, to include a bloody lip/mouth, from being beaten by Garcia and suspect two. Demarco is approximately 5'8"/140lbs. Within a few days following this robbery incident, Demarco showed extensive bruising over his entire body; which was photographed.

Upon walking through Demarco's home, it was very apparent he's an established resident. He had his own nightstand, filled with his personal belongings, numerous articles of clothing in their dresser drawers and closet and his hygiene items neatly organized inside their bathroom. I photographed Demarco's belongings, in place, for evidentiary purposes.

On 06/08/2020 I authored a probable cause affidavit properly charging Oscar Garcia. The persons warrant was reviewed and authorized by the Honorable Judge August Bonavita.

I requested the PBSO Tactical Unit locate and arrest Garcia.

On 06/11/2020 TAC located and arrested Garcia at 8191 W. Commercial Blvd. #110, Tamarac, FL.

Following Garcia's arrest, I was contacted by an attorney, who advised he may be representing Garcia and co-defendant, Louis Pignatore.

Upon viewing a DAVID picture of Pignatore I recognized him as the unknown suspect.

On 06/11/2020 I prepared a photo array to be shown to Anthony Demarco, utilizing the Intellitech System. A photo of Louis Pignatore was placed in position number 2, along with five similar looking persons.

On 06/11/2020, at 1024hrs, Detective J. Lawless #12469 presented Demarco with the prepared photo array. Demarco pointed to the photo in position number 2, Louis Pignatore, and positively identified him as the same person who had robbed him on 06/02/2020.

Upon further review of the videos, taken by Demarco, I observed the following. For two of the three videos, equaling approximately 20 minutes, Garcia has Claudia Perlman on speaker phone. With Demarco cornered by Garcia and Pignatore, Claudia repeatedly directs Demarco to immediately leave the house; insinuating because she's the owner, he doesn't have the right to his current residency. Demarco asks them several times, "Please, just call the Police", which Claudia declines by saying "No, get your stuff and get out of my house." Claudia says she sent her family, Garcia and Pignatore "there" to "help her" and "They'll make sure he leaves." Pignatore tells Claudia to call 911 and stage a burglary to the residence, advising Law Enforcement that Demarco is currently breaking into the home (Oxford Place #A). Pignatore further states "They'll take all this evidence, referring to Demarco's cell phone, and smash it to smithereens and then he'll get one fucking beating like he's never gotten in his life." Pignatore then follows up by saying they should "Baker Act" him (Demarco) out of the

residence. Demarco asks Claudia for time to move out and she responds by stating "I've given you enough time." During the incident Claudia refers to suspect two by the name "Louis." It's clear Claudia Perlman sent Garcia and Pignotore, to Demarco's home, to remove him by any means necessary.

Demarco refers to Claudia Perlman by name, several times, during the above conversation and identifies the voice as belonging to her.

Due to the above Louis Pignatore and Claudia Perlman are in violation of FSS 812.13(1)(2) reference Robbery No Weapon or Firearm and FSS 810.02(1)(2)(a) reference Burglary with a Battery.

It should be noted, on 06/03/2020, I was contacted by Sgt. M. Donovan #9132, who advised PBSO dispatch had received a call, that Demarco was threatening to harm himself and others; specifically Law Enforcement. Sgt. Donovan, knowing I had rapport with Demarco, asked me to contact him and have him step outside his residence (23048 Oxford Place #A). Upon calling and speaking with Demarco, it was discovered he was completely unaware of such current threat and immediately exited to meet with Sgt. Donovan. While PBSO Deputies were talking to Demarco, a medical doctor, Jonathan Greenfield (FL medical license number 81326), who had prepositioned himself at the community clubhouse, approached and handed them a "Baker Act" form for Demarco. It appeared this "Baker Act" was generated by Claudia Perlman and her family members, the suspect robbers in this case. PBSO Deputies detained Demarco and transported him to the South County Mental Health Center (16158 S. Military Trail, Delray Beach). Once there, Demarco called and told me his work boss had went to his (Demarco's) residence to retrieve his dog and personal belongings. Demarco stated his \$1700 cash currency had been stolen and personal effects were now damaged. The above evidentiary pictures, I took on the day prior (robbery incident date), showed Demarco's monies and belongings. I was then contacted by South County Mental Health Center Doctor, Annmarie Laughlin, who advised she had been unaware Demarco was the victim of a violent crime on the day previous because the doctor, who authorized the "Baker Act", made no mention of it on the BA form. Dr. Laughlin further stated she was immediately releasing Demarco, as she finds he does not suffer from mental illness and is currently showing no signs that he wants to harm himself or others.

It's apparent, due to Claudia Perlman's previous failed attempts to remove Demarco from his place of residence, even by the use of physical force, led to the said "Baker Act", to bypass his proper removal, through a legal eviction process.

I spoke Dr. Greenfield, who advised he was contacted by the Perlman's (on 06/02/2020), who had convinced him Demarco was an active real time threat to himself

and/or others; However failed to mention their family members had committed a violent crime against him on that same day. Dr. Greenfield was appalled that he was unknowingly used as a means for the removal of Demarco from his residence and to interrupt the on-going robbery investigation

Dr. Greenfield stated Jemma and Tyler Perlman communicated to him that Demarco, in real time, was threatening to shoot the police and their family. Tyler also messaged Dr. Greenfield ""Thank you. Just know he's armed and dangerous already attacked my uncle (Garcia). I really wish I can take this into my own hands. But my wife is pregnant and wants to kill me already for dealing with it." This message was sent shortly after Demarco was in fact "attacked" by Garcia, not Garcia attacked by Demarco. Tyler then provided Dr. Greenfield with a video and a screenshot of his own Facebook page. The video showed Demarco holding an airsoft handgun, near his head, while pulling the trigger. Tyler's Facebook page read "So sad I can't even help my own family out. The COPS won't even help me. This kid is going to literally end up hurting my family and action needs to take place ASAP. He's threatening me, my sister, my mother, my niece. Says he's going to kill us all and this moment he is sitting on my front..."(The remainder cannot be viewed). The pictured screen shot shows a message thread, in which Tyler claims came from Demarco. Tyler's stated Facebook post is time stamped 3:18PM (06/02/2020). Again, only hours after Demarco was victimized by the Perlmans.

Jemma and Tyler were both aware of this robbery investigation prior to misleading Dr. Greenfield. I had spoken to Jemma, via her cell phone, and Tyler was present on-scene.

Greenfield provided me with copies of the stated items given to him by Tyler Perlman. He also reiterated that Jemma and Tyler Perlman both presented to him that Demarco was an active real time threat to the community.

After speaking with Dr. Greenfield I made contact with Demarco. Demarco stated he's familiar with the said video Tyler provided Dr. Greenfield. Demarco advised that specific video was posted on his public social media account on/or about September 2019 and has never been directly distributed to the Perlman family in any manner. Demarco presented me with a picture, proving the viewed handgun to be an airsoft toy. Demarco told me he's never sent threatening messages to any Perlman family member. Demarco stated Jemma is a heavy opiate drug user, which caused her to be very manipulative throughout their relationship. Demarco said Jemma would manufacture messages between him and her family in order to create conflict, so she could "get her way."

NARRATIVE CONTINUATION

Jemma and Tyler Perlman used the fabricated Baker Act as a form of retaliation, an act of intimidation towards Demarco, for reporting being the victim of a violent crime; at the hands of his uncle, Oscar Garcia and close family friend, Louis Pignatore and to disrupt Law Enforcement's investigation of the stated robbery incident. The Baker Act hindered Detectives ability to continue investigating due to Demarco being detained within the South County Mental Health facility. Demarco has told me multiple times he fears for his life and is concerned about what form of retaliation may come next; from the Perlman family.



Between the stated Baker Act and 06/12/2020 Jemma and Tyler have contacted Law Enforcement, on at least two occasions, attempting to report crimes; naming Demarco as the suspect. Both cases were unfounded.

Prior to this robbery incident, the Perlman's have never reported a crime incident against Demarco. Demarco has no current arrest history.

On 06/03/2020, using the erroneous circumstances, Jemma obtained a protection order against Demarco, which was served on him at the South County Mental Health Facility. Demarco contacted me on 06/14/2020, advising, at 0223hrs, Jemma began texting him from an unknown number (APP number 305-305-1436); ultimately calling him. Demarco confirmed it was her voice on the other end of the line. Demarco stated Jemma was attempting gain his confidence, so he'd contact her in return. Demarco knew that would be a direct violation of the current no contact order; therefore he refused. Demarco told me Jemma sent him multiple videos that she had created, showing pictures from their relationship. Demarco provided me with a copy of the stated messaging and videos.

NARRATIVE CONTINUATION

Due to the above Jemma and Tyler Perlman are in violation of FSS 914.22 (1)(a)(e) reference Tampering with a Witness in a 1st Degree Felony Proceeding by using intimidation to withhold testimony and by hindering, delaying or preventing communication to Law Enforcement relating to the commission of an offense and FSS 787.02(1a) reference False Imprisonment for using Dr. Greenfield as an instrument to unlawfully remove Demarco, from his place of residency, to the South County Mental Health Center.
