On Monday, March 16, 2020, approximately 12:00 am, I Trooper Warren N Reid was dispatched to a traffic crash, which occurred at State Road 60 and Mulrennan Road intersection. Upon arrival, I spoke with Hillsborough County Deputies on scene who directed me to the vehicle driven by the defendant. As I walked towards the vehicle I observe the defendant sitting in the driver's seat who was positively identified as the driver. I walked up to the driver's door and while talking to the defendant, I could smell the strong odor of consumed alcohol, coming from her breath. I also noticed her slurring in her speech and her eyes pale and glossy.

After completing the crash investigation, I informed the defendant that I had concluded the crash investigation and was about to conduct a criminal investigation for DUI. Defendant was unable to perform Field Sobriety Exercises satisfactorily and was then arrested for DUI. This offense was committed in Hillsborough County.
