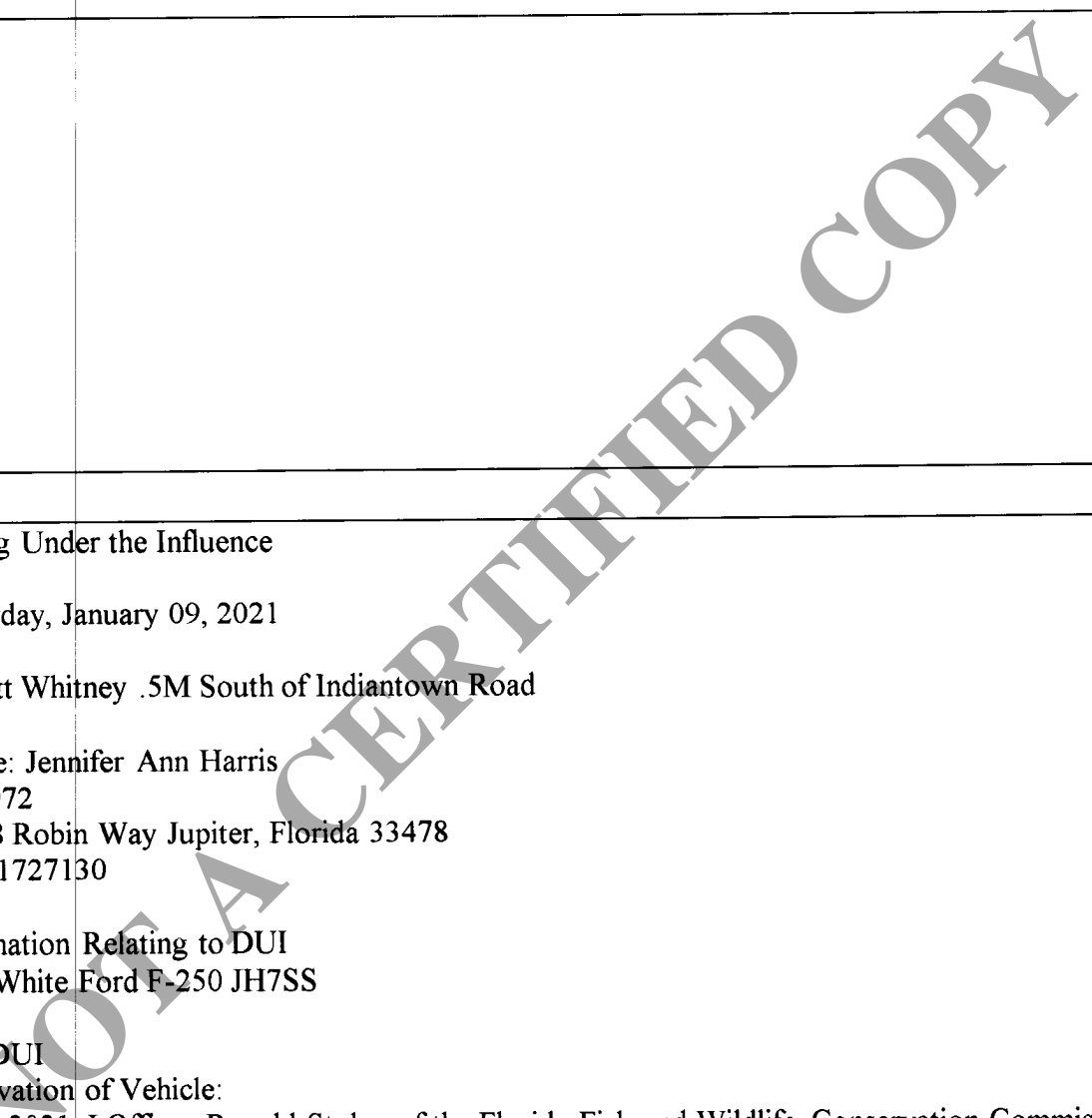
**VI. Details of DUI**

**A. Initial Observation of Vehicle:**

On January 09, 2021, I Officer Ronald Stoker of the Florida Fish and Wildlife Conservation Commission (FWC) was headed West on Indiantown Road in my marked patrol vehicle in Palm Beach County, Florida when I observed a White Ford Pickup traveling West at approximately 30 miles per hour. The posted speed limit is 55 miles per hour. I observed the vehicle swerving from left to right going in and out of its lane. When the vehicle made a left turn on Pratt Whitney it came to a complete stop when it had a green light and there was no oncoming traffic. At approximately 2331 hours I activated my vehicle's emergency lights and siren and conducted a traffic stop to address the violation.

**B. Personal Contact with Operator**

I introduced myself as Officer Stoker with FWC and informed the operator of the reason of the stop. Upon making contact with the operator of the vehicle, later identified by her FLDL H620421727130 as Jennifer Harris I observed multiple signs of impairment. Mrs. Harris's eyes were bloodshot and glassy. Her speech was slow and slurred, speaking with a thick tongue. Mrs. Harris's breath emitted a strong odor of an unknown alcoholic

slurred, speaking with a thick tongue. Mrs. Harris's breath emitted a strong odor of an unknown alcoholic beverage. Mrs. Harris stated she had been drinking at Uncle Micks in Jupiter. When asked to produce her driver's license, proof of insurance, and registration for the vehicle, Mrs. Harris struggled to complete the task. She turned on the vehicle's interior lights and stared at me for further direction. I asked Mrs. Harris for a second time to produce the information I needed. Based on the clues I observed with my interaction, I asked Mrs. Harris to step out of the vehicle to complete Standardized Field Sobriety Tasks, at which point she did not place the vehicle in park and tried to exit the vehicle while it was still in gear. Mrs. Harris struggled to stand up without having to brace herself. I had to catch her multiple times so she did not fall.

VI. Details of DUI

A. Initial Observation of Vehicle:

### B. Personal Contact with Operator

I introduced myself as Officer Stoker with FWC and informed the operator of the reason of the stop. Upon making contact with the operator of the vehicle, later identified by her FLDL H620421727130 as Jennifer Harris I observed multiple signs of impairment. Mrs. Harris's eyes were bloodshot and glassy. Her speech was slow and slurred, speaking with a thick tongue. Mrs. Harris's breath emitted a strong odor of an unknown alcoholic beverage. Mrs. Harris stated she had been drinking at Uncle Micks in Jupiter and that's where she was coming from. When asked to produce her driver's license, proof of insurance, and registration for the vehicle, Mrs. Harris struggled to complete the task. She turned on the vehicle's interior lights and stared at me for further direction. I asked Mrs. Harris for a second time to produce the information required. She located her license in a wallet that was attached to the keys in the ignition but struggled to get her driver's license out of it. Based on the clues I observed with my interaction, I asked Mrs. Harris to step out of the vehicle to complete Standardized Field Sobriety Tasks. Mrs. Harris tried to exit the vehicle while it was still in drive. I had to yell loud verbal commands for her to put the truck in park and turn it off before getting out of the vehicle. While outside of the vehicle Mrs. Harris had a hard time maintaining her balance and had to be assisted multiple times so she did not fall.

### C. Completion of Standardized Field Sobriety Tasks

#### Horizontal Gaze Nystagmus

Mrs. Harris refused to consent to HGN.

#### Walk and Turn

Mrs. Harris refused to complete the walk and turn.

#### One-Legged Stand

Mrs. Harris refused to complete the one-legged stand.

#### Arrest of Operator

Based on the physical indicators I observed, at 2343 Hours I placed Mrs. Harris under arrest for the suspicion of driving under the influence. Mrs. Harris was informed of her Taylor Warnings when she refused to complete the Field Sobriety Exercises. At 0035 hours, Mrs. Harris refused to consent to a lawful test of her breath to determine its alcoholic content. Upon inventorying the vehicle, an open container of Bud Light was found on the passenger side of the of the vehicle's center console. I photographed the bottle with my agency issued body camera.

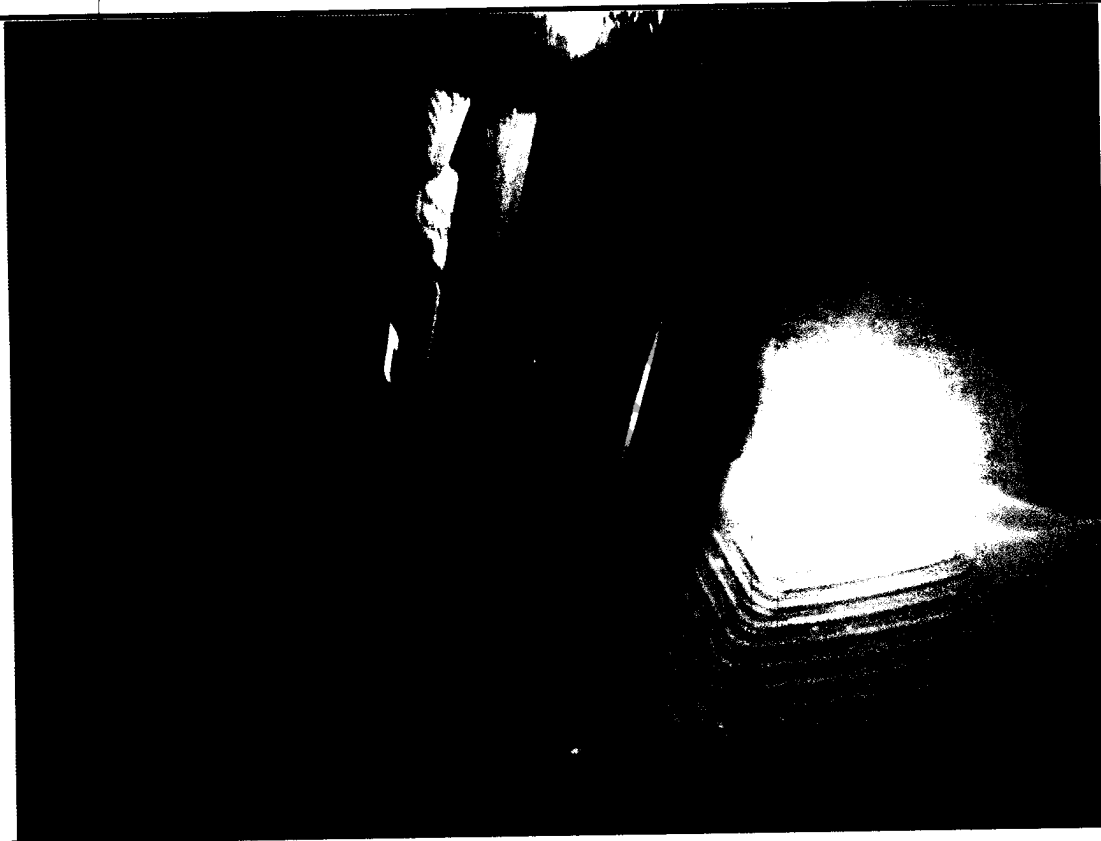
