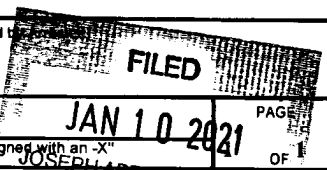

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

Officer Hanton #305 was westbound on Northlake Boulevard and Interstate 95 in Palm Beach Gardens, FL when second traffic light for I95 turned green. Officer Hanton began to go through the intersection when a black Hyundai bearing Florida plate UYK5F ran the red light, exiting I95 onto Northlake Blvd and went westbound. The Hyundai crossed all 3 straight lanes and entered the left turn lane for 4200 Northlake Blvd Plaza (Gardens Town Square). The left turn arrow was red and the Hyundai changed lanes, entering the left straight lane, then entered the left turn lane for Dania Dr when Officer Hanton initiated the traffic stop. Officer Hanton identified the driver via her Florida Driver's License. when i stopped her. driver had to be reminded to provide reg and insurance, odor of unk alcoholic beverage from veh, bloodshot glassy eyes

OBSERVATION OF DRIVER:

Officer Hanton noted to me that White had bloodshot, glassy eyes and had the odor of an unknown alcoholic beverage coming from her breath. White had to be reminded multiple times to provide her registration and her insurance.

Upon my contact with White, her speech was slurred and mumbled. She had bloodshot glassy eyes, the odor of an unknown alcoholic beverage, which grew stronger as she spoke, and was unable to follow instructions during SFST's.

***Search incident to arrest of White yielded possession of .06g of (confessed) Marijuana in her left front pocket and a small pipe. PC for the possession charges.

DRIVER'S STATEMENTS:

Difficult in providing medical history; stated she had a lazy right eye (but during Q&A stated nothing was wrong with her eyes). Stated she was coming from Uncle Mic's in Jupiter where she had two glasses of wine and was headed to Crazy Horse Saloon to drop her friends truck off (no other vehicle but her friend was with her). She corrected her statement, stating she was going to drop him off and they were going to eat dinner at Crazy Horse. Post Miranda: Last ate at breakfast (cheese sandwich), drank two glasses of wine at Uncle Mic's where there was a party, smoked marijuana before driving south on I95 to get to Crazy Horse.

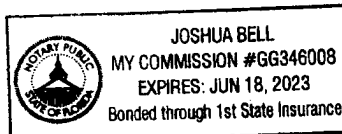

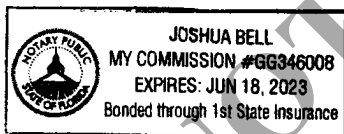

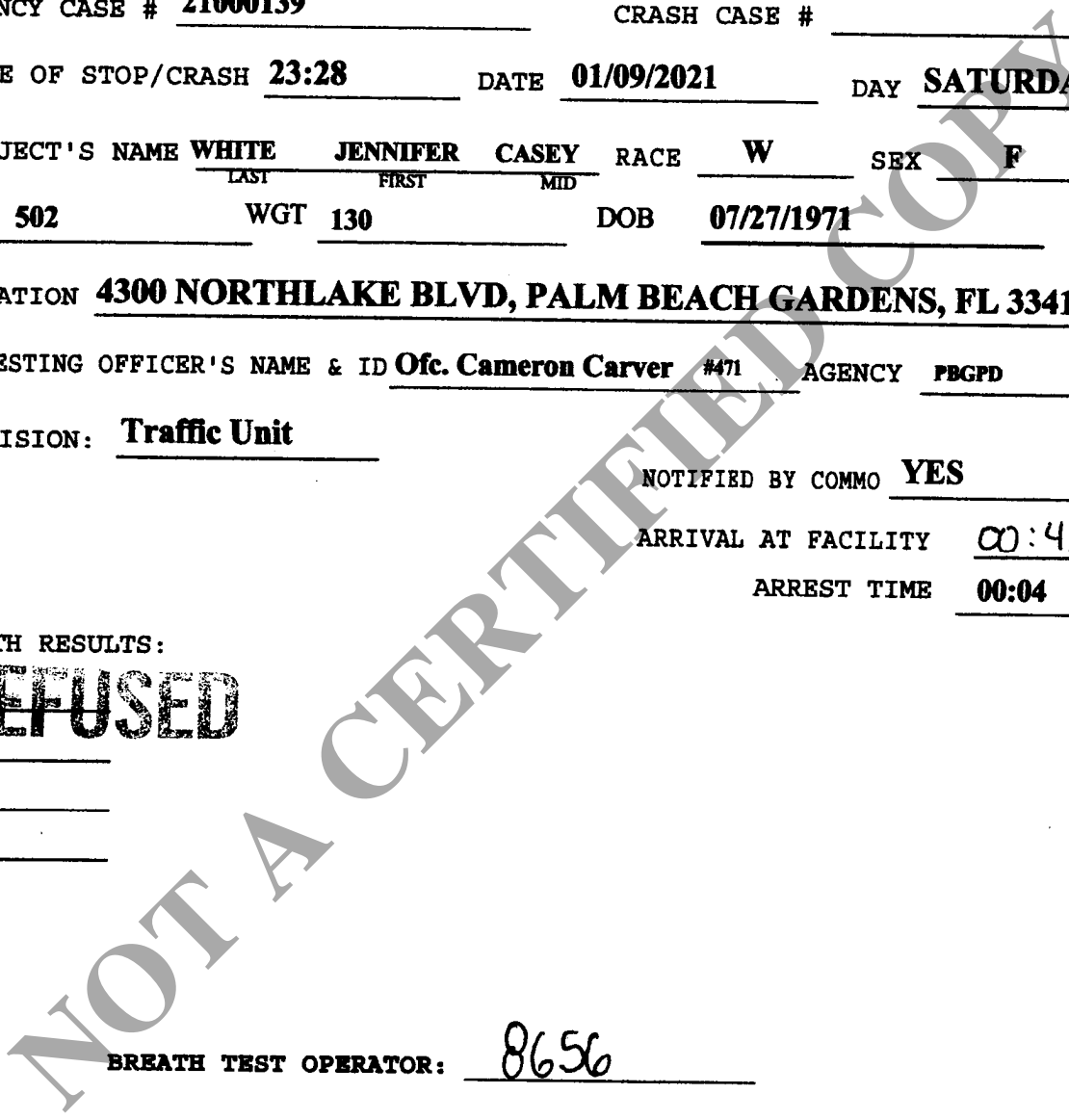
