The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 11/25/2020, at approximately 0132 hours, at Gornto Lake Rd. S. / Bloomingdale Av., Riverview FL 33578, Corporal Morton (ABN 145983) responded to a traffic crash call for service involving a blue Acura (bearing FL tag: HMDT42 / VIN: 5J8TC1H33LL002239) and was first to arrive on scene. Upon making contact with the defendant, Corporal Morton observed her to have slurred speech, glassy, watery bloodshot eyes, and he detected the odor of an alcoholic beverage emanating from her breath. Deputy Tejada (ABN 254169) responded and completed the traffic crash investigation (see HCSO 20-761768 and DHSMV 89437464). The witness observed the defendant behind the wheel and in actual physical control of the above listed vehicle. During her investigation, Deputy Tejada observed the same indicators of impairment. She also observed the defendant to be disoriented and did not know the direction she was going/coming from. Upon my arrival, I observed the same indicators of impairment listed above. The defendant was given the opportunity to perform field sobriety exercises, which she did poorly, indicating impairment. Subsequent to arrest, the defendant provided breath samples of .223/.217 after a twenty minute observation period. The defendant was identified via their Florida driver's license.
