

On the 21 day of February, 2020 at 00:15 (Specifically include facts constituting cause for arrest.)

On the above date at approximately 0015 hours I was dispatched to the McDonald's Restaurant located at 6761 West Indiantown Road in the Town of Jupiter, Palm Beach County, Florida, in reference to a disturbance.

I was in an unmarked police vehicle. As the eventual stop in this case was based on my training and experience, a brief description of it follows: I am an experienced DUI enforcement officer with over 350 career DUI arrests. I have attended over 400 hours of DUI related advanced training classes. I am a certified Drug Recognition Expert Instructor and SFST instructor. I regularly travel across the state to teach the 24 hour SFST course, 16 hour ARIDE course and 72 hour Drug Recognition Expert School to officers from across the state of Florida. I have taught DUI related classes on behalf of the Jupiter Police Department, the Florida Highway Patrol and Institute of Police Technology and Management.

An employee, Antoria, called Jupiter Police Dispatch to advise a female in a white Jeep bearing Florida license plate RLA827 was in the drive thru lane causing a disturbance and refusing to leave. Per the call notes provided by Jupiter Police Dispatch the caller stated the driver was possibly intoxicated. Before I could get to the scene, the female reportedly left eastbound on West Indiantown Road. I was east of the restaurant traveling south on North Central Boulevard approaching the intersection with West Indiantown Road. I observed a vehicle matching the description (and I later observed with the same license plate) turn from eastbound West Indiantown Road onto northbound North Central Boulevard. I made a u-turn and began to follow the vehicle. I observed the vehicle swerve over the white fog line on the right hand side of the roadway as it approached the intersection with Longshore Drive. As the vehicle traveled north on Longshore Drive, it swerved several times. It turned right onto Still Lake Drive. The vehicle made a wide right hand turn (an explicitly recognized strong indicator of a possibly impaired driver) and drove over the solid yellow double lines on Still Lake

right on the fourth step. Johnson tripped over her feet on the fifth step and missed heel to toe. Johnson missed heel to toe on the sixth step and used her arms for balance. Johnson missed heel to toe on the remaining steps.

I next conducted the One Leg Stand. Johnson put her foot down on "1000-7." Johnson was swaying and used her arms for balance throughout. Johnson picked up her other foot and started counting over. Johnson placed her foot down on "1000-2" and again on "1000-5." Johnson then stopped and put her hands on her hips, staring at me. I asked Johnson to continue. Johnson started over again. I ended the task as Johnson reached "1000-7." Johnson continued to sway and use her arms for balance.

I next conducted the Finger to Nose task. I observed the following: L1: Johnson used the pad of her finger to touch the tip of her nose. Johnson forgot to return her finger to the side. I reminded her to in future. R2: Johnson used the pad of her finger to touch her right cheek next to her nose. L3: Johnson used the pad of her finger to touch the tip of her nose. R4: Johnson used the pad of her finger to touch the tip of her nose. R5: Johnson at first used the wrong hand, then switched, then used the pad of her finger to touch the tip of her nose. L6: Johnson used the pad of her finger to touch the tip of her nose.

I then conducted the Romberg / Alphabet task. Johnson stated she was comfortable with the alphabet. Johnson was swaying during the task. Johnson stated the alphabet as follows: A B C D E F G H I J K L M N O P Q R S T U V. Johnson then asked to start over, saying she was nervous. I allowed her to. Johnson stated the alphabet the second time as follows: A B C D E F G H I J K L M N O P Q R S T U V. Johnson apologized twice.

At that time I placed Johnson under arrest for DUI and advised her. I secured Johnson in handcuffs which I checked for spacing and double locked. I then transported Johnson to the Palm Beach County Breath Alcohol Testing Facility where I conducted a 20 minute observation period. I then requested Johnson provide a sample of her breath. Johnson declined. I read Implied Consent to Johnson. Johnson stated she didn't understand. I explained each sentence to Johnson in simpler language. Johnson stated she understood and again declined to provide a sample of her breath. I then read Johnson her Miranda Rights. Johnson declined to speak to me. I noted Johnson's driver's license return from DHSMV indicated a prior refusal to submit. I secured Johnson in a holding cell while I completed my paperwork. I then booked Johnson into the Palm Beach County Jail where I charged her with the following offenses per Florida State Statute: DUI per FSS 316.193(1) and Refusal to Submit to Lawful Test of Breath / Urine per FSS 316.1939(1).

My on scene investigation was captured on my issued body worn camera. I later uploaded my dash camera to evidence.com for future use in this case.



Drive with its driver's side tires. Based on my observations and the citizen caller's report of possible intoxication and reportedly disruptive antisocial behavior, I was concerned the driver was impaired. I initiated an investigative traffic stop of the vehicle as it traveled on Still Lake Drive.

I walked up to the driver's side door, which the driver, Jennifer Johnson, opened. I immediately noticed Johnson's eyes were glassy and the interior of the vehicle had the odor of an unknown alcoholic beverage. Johnson was evasive and dismissive of the incident at the McDonald's. Johnson repeated several times she was just trying to get a coffee and was unable to clearly explain what occurred. I started to ask Johnson about how much she'd had to drink. Johnson indicated she had been kayaking earlier and had a "couple" of beers. I later asked Johnson again how much she'd had to drink and she was evasive. Several times while speaking to me Johnson became evasive or trailed off while talkative and I noticed her speech was slurred. None of my interaction with Johnson dispelled (but substantially increased) my concern she was impaired. I set up an area just behind her vehicle to conduct roadside tasks.

I asked Johnson to exit her vehicle. As Johnson did so, she appeared unsteady on her feet as she walked towards me. As I started speaking to Johnson, she suddenly walked back towards her car asking me to hold on. I tried to get her attention but Johnson ignored me. I yelled loudly to Johnson to order her to stop. Johnson returned to where I asked her, acting offended by what just occurred. Johnson then started asking me to call her cousin, who I know as a police officer. I refused and Johnson became argumentative for several minutes while I repeatedly refused to call him. I then asked Johnson to complete roadside tasks. Johnson asked a question to the effect of what would happen if she didn't, and I advised her of Taylor Warnings. Johnson agreed to complete roadside tasks.

I first conducted the Horizontal Gaze Nystagmus. I am a certified Drug Recognition Expert and conducted the task in a manner consistent with my training. I observed all six signs of Horizontal Gaze Nystagmus. Lack of Smooth Pursuit, Distinct and Sustained Nystagmus at Maximum Deviation and Onset of Nystagmus prior to 45 degrees were present in both of Johnson's eyes. Johnson became impatient with me several times during the task but was able to complete it. I did not observe vertical gaze nystagmus.

I next conducted the Walk and Turn task. Johnson had flip flops on and took them off prior to the task. Johnson lost her balance twice from the starting position. Johnson's gait was poor as she started the task. Johnson stepped off the line and missed heel to toe on the fourth step and stepped off to the other side as she attempted to return to a heel to toe position. Johnson used her arms for balance. Johnson stepped off the line on the sixth step and used her arms for balance for several more steps. Johnson took eight steps but counted nine. Johnson missed heel to toe on the third step on the return. Johnson missed heel to toe and stepped off the line to the
