NARRATIVE:

On 02-16-22, at approximately 1830hrs, I, Detective R. Fuentes #24989, was tasked with assisting PBSO District 1 deputies with PBSO case #22-036917. I conducted a review of the aforementioned case, which consisted of the following information:

On 02-16-22, at approximately 1748hrs, PBSO D/S Stockwell #18352, was dispatched to 9111 Winterhaven Circle West Palm Beach, FL 33411, in reference to a welfare check on Freedland. The welfare check stemmed from Freedland allegedly making threats while on the telephone with Medicare Customer Service Representative, Khadine Kissoon. According to Kissoon, Freedland was denied food stamps by the Department of Children's and Families, which agitated her. Freedland then allegedly told Kissoon that she would "go to the government and bomb them", referring to DCF. Freedland then allegedly followed up her bombing statement with "don't be surprised when you see me going to jail because I shot the place", once again, referring to DCF. Kissoon advised that the conversation was audio recorded. Kissoon was then able to put deputies in contact with the Security Director of Maximus Federal, Tom Ward, via telephone. Ward advised he would provide a copy of the recorded telephone call to Detectives in the immediate future for the safety of the public.

On 02-16-22, at approximately 2116hrs, Detectives and I responded to Freedland's home address in order to speak to her. I was then met with her elderly mother, Darryle Forrest, who advised that Freedland was currently in the state of New York and does not know when she will return.

NARRATIVE CONTINUATION

On 02-17-22, at approximately 1330hrs, I received correspondence from Ward, in reference to the recorded phone call from Freedland to the Medicare Customer Service help line. I observed the recorded phone conversation to be approximately 28 minutes and 44 seconds long. I listened to the recorded phone call, which Freedland voiced her frustration due to being placed on hold for 4 hours and then being denied services.

While listening to the recorded phone call, I heard the following statements from Freedland, which are time-stamped in chronological order:

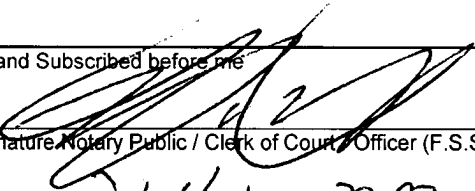
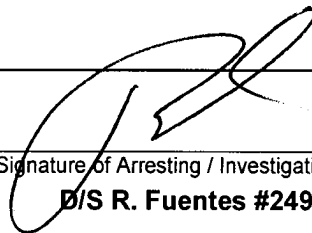
- 2:19 - Freedland identified herself as "Jennifer".
- 2:25 - "I want to go to the government and light a bomb and watch them explode and laugh. I'll be happy to spend my life in jail. I don't care that this is a recorded line. No wonder people shoot places".
- 5:23 - "When I go down there I'm going to shoot somebody up".
- 6:02 - "When somebody get's shot, it's going to be too late."
- 8:56 - The call taker asks Freedland if she is speaking out of frustration or means what she says. Freedland then replies "Maybe if you fix the situation I wouldn't be so likely to take action on my word".
- 11:38 - "DCF is the worst government agency there is".
- 24:29 - "I'm just about ready to kill someone and that's literal, not figuratively."
- 24:35 - "I'm just about to shoot somebody, you will hear about this on the news".

During the above phone conversation, Freedland made it aware that her agitation and threats were directed specifically at the Department of Children's and Families. The above recorded phone conversation was submitted in PBSO evidence. Contact was not made with Freedland at this time, due to her unknown current location.

Based on the above investigation and evidence provided to me, probable cause was established for the arrest of Freedland for Threatening to Discharge Destructive Device pursuant to F.S.S 790.162.

Freedland did unlawfully threaten to throw, place, project, or discharge any destructive device with intent to do bodily harm to any person or with intent to do damage to any property of any person.
