The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 02/20/2021, at approximately 02135 hours, Deputy D. Millard (ABN:258018) responded to the above listed location in response to a wrong way driver call for service. Deputy D. Millard located a vehicle matching the description of the vehicle in the call stopped on the side of the road with the driver sitting in the driver's seat and the engine running. Upon contact with the defendant, the affiant detected the strong odor of an alcoholic beverage emanating from the defendant's breath, observed her eyes to be red/bloodshot and watery, her movements to be slow and lethargic, her speech to be slurred, and her to have unsteady balance. The affiant requested the defendant to perform Standard Field Sobriety Exercises (SFSEs), which the defendant agreed to do. During the SFSEs, the defendant showed multiple signs of impairment and was subsequently arrested for DUI. The defendant was transported to CBT where she refused to provide lawful samples of her breath after Implied Consent was read and understood. The defendant was positively identified via her valid Florida driver's license.
