The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: subject committed title fraud by obtaining a duplicate title that belonged to Calvin Fairweather, she had power of attorney for an ex boyfriend named albert scowden who is in jail.
