The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

The defendant was operating a gray 2020 Land Rover, 4 door SUV, Florida tag HMEK15. The defendant drove in a manner in which the vehicle tires drove on top of the outer painted lane markers, and drifted in the travel lane. The defendant drove at unlawful speeds, traveling 85 MPH in a properly posted 55 MPH speed limit. The defendant failed to stop for a steady red traffic light as she made a right turn that was also controlled by a "no turn on red" traffic control device. The defendant had a distinct odor of an alcoholic beverage on her breath. The defendant's eyes were bloodshot and watery, and her face was flushed. The defendant stated that she drank several alcoholic beverages throughout the day. The defendant was unsteady exiting the vehicle, and swayed slightly while standing. The defendant was interruptive and passive aggressive confrontational. The defendant agreed to perform Field Sobriety Exercises. The defendant exhibited signs and clues of impairment, and was arrested for DUI. The defendant provided breath samples of .043 and .036. During a search of the defendant's purse, numerous prescription medications were found, along with a cannabis sativa vape cartridge. The defendant stated that some of the pills were prescribed and some were previously prescribed to her. The defendant was positively identified by her Florida DL.
