The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 On 02/03/2020, at approximately 0217 hours, Deputy J. Shannon (ABN 250892) was traveling northbound on North Dale Mabry hwy, when he observed a gray Volkswagen Jetta, bearing Ohio tag HUQ1415, with an assigned VIN of 3VWCB7BU2KM128785, to be traveling in front of his marked patrol vehicle. This vehicle was swerving abruptly from left to right, striking the solid white line and dashed white line multiple times. Deputy Shannon conducted a traffic stop on this vehicle at the intersection of North Dale Mabry Hwy and Exciting Idlewild Blvd, to check on the well being of the driver to see whether they were ill, tired or impaired. Upon contact with the defendant, he had bloodshot glassy eyes, slurred speech, fumbling fingers and the distinct odor of an alcoholic beverage emitted from his breath as he spoke. The defendant was asked to participate in the Standardized Field Sobriety Exercises, which he refused. Based on the totality, the defendant was placed under arrest for DUI. Implied consent was read and the defendant then refused to provide a lawful sample of his breath. The defendant was positively identified via his valid Florida driver's license. A query of the defendant revealed he has a prior refusal to submit to any sobriety test on 12/16/2009.
