The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did																																									
The defendant was driving a white Honda SUV bearing FL tag 67AETC. I observed the vehicle northbound on Howard Av S and noted that it was weaving in its lane. As we approached the traffic signal at Howard Av S / Cleveland St, the vehicle activated its left turn signal then straddled the lane line between the through lane and the turn lane. As the signal changed green the vehicle continued northbound, driving through a painted safety zone, before making a short turn westbound onto Kennedy Bv W, through the eastbound lanes of travel. The vehicle continued to weave in its lane and accelerated quickly. I paced the vehicle at over 50 mph, with a top speed of 55 mph, in a 40 mph zone. The vehicle continued to weave in its lane before making a prolonged lane change from the inside to outside lane. I conducted a traffic stop on the vehicle for the speed violation, as well as to check on the welfare of the driver as I suspected him to be sick, injured or impaired. Upon contact with the defendant, I observed him to have bloodshot and glassy eyes and his speech was slow and slurred. I detected the odor of an alcoholic beverage emanating from his breath, and he admitted to having "2 glasses of wine". The defendant participated in SFSE's which showed further indicators of impairment and was subsequently arrested for DUI.																																									
The defendant provided breath samples of .218/ .221 .																																									
The defendant was ID'ed via MA DL.
