On the 20 day of February, 2021 at 21:20 (Specifically include facts constituting cause for arrest.)

On Saturday, February 20, 2021, at approximately 2120hrs, I responded to 1267 Main St, in reference to a disturbance that was occurring at the front stage of a concert.

Upon arrival, I made contact with Sgt.Cade who is employed with the School Board Police Department. Sgt.Cade was working an extra duty detail for the Town of Jupiter as designated per our Mutual Aid Agreement between the Town of Jupiter and School Board Police. Sgt.Cade was in full uniform and working in full capacity as a Law Enforcement officer within the Town of Jupiter at the above noted date.

Sgt.Cade stated to me that W/M Jeremiah D Burke (02/23/1988), was at the above noted address causing a disturbance within the crowd. Jeremiah had a large tray of beers and was attempting to push through the crowd to hand drinks to the band playing, Jeremiah had done this too many times and was disturbing the band and patrons around him. A security officer later identified as W/M James Rukosky (12/04/1962), attempted to get James to leave but James yelled at him and told him to "fuck off". James then notified Sgt.Cade who asked Jeremiah to leave again. James continued to argue and refused to leave. Sgt.Cade then attempted to escort Jeremiah out of the concert.

Jeremiah then quickly grabbed onto a nearby rail and refused to let go. Other officers at the concert intervened in an attempt to assist Sgt.Cade. Jerimiah was removed from the rail and he still tried to pull away from Sgt.Cade. Jerimiah was eventually placed into handcuffs and escorted out of the concert. See Sgt.Cade's report for further (School Board Police Case 2100000297).

I then made contact with James and he provided me with a sworn video-recorded statement in which he told me that James had also intentionally struck him in the left eye causing a minor abrasion. I did see a small red abrasion under James left eye witch was approximately the size of a dime.

While working a detail with Jupiter PD at the abacoa town center amphitheater, I was monitoring the stage area whe I was alerted by event security of a drunk Irate male. Upon my arrival I could see a male later identified as Jeremiah Burke W/M 2/23/1988 cursing at the event staff. Burke had a strong order of alcohol coming from his person and was verbally refusing to leave. BURke had a total disregard for police and security staff.

Burke was given a custodial touch to the center of his back and asked by this office to leave the property. Brke pulled away and grabbed the railing in an attempt to remain. Burke was then place in a hammer lock and escorted out of the event. When beig escorted out of the event Burke began to pullaway causing officers to take his to the ground and handcuff him for oficer safety. Burke was then escorted out of the event without further incndent.

Based on the above facts I find sufficient probable cause to charge Jeremiah Burke Persuant to F.S.S. 877.03 Disorderly Conduct and F.S.S. 843.02 Resisting Without Violence
