	On Wednesday, April 1, 2020 at approximately 1038 hours I responded to 1105 N Dixie Hwy (RDT DEVELOPMENT), in reference to Criminal damage to property (vandalism). Upon arrival I observed the following:					
	The entrance to the business faces south toward 10th St. I observed large graffiti writings all along the four walls of the business (pictures taken). I also observed an envelope on the floor with the letter (D) on the front, paintings, and strange objects like mannequins sitting next to the front door. The back of the business (west side) had electric wires hanging as if someone willfully and maliciously tried to damage its connections.					
	I met with the caller who is the receptionist of the business Mandy Burkart who advised she observed a male who she knows as Jerome Bianco writing on the walls. Burkart then called the police prior to Bianco fleeing the scene. The representative of the business arrived on scene and was identified as Edward Grace. Grace stated the following:					
A D M I N I S T R A T I V E	Grace stated that Bianco was an assistant to a person who he used to conduct business with (John D. Williams W/M DOB 05/24/88). Grace said the business was concluded but Bianco kept sending emails and text's as if he was still owed something.					
	Grace stated for the past four days Bianco has been sending numerous emails, and text messages to him. Grace further stated that the emails and texts are very odd, and even threatening. Grace fears that Bianco would cause not only loss to his company but harm to his person. Grace stated that the acts of vandalism started to happen as he kept receiving these threatening emails and text messages. Grace advised that Bianco is also trying to extort him and one of the text messages I read states the following:					
	"I'm sending you both an order of service; Dack yours will be for 113k, Ned (Edwards

nickname) yours will work for 9 million dollars. These service orders will be signed, and I will send you my wire instructions once signed. I'm not fucking around anymore. Whether you kick me out of 542 or not, non of this is going away. I don't know who is doing these acts of vandalism but I'm certain that it will continue. It doesn't matter if I'm not in the area or not. This is my neighborhood. It will continue"

Grace stated that Bianco came to the business and Graffiti the building multiple times. Grace documented the incident with police the day before, and on today's date Bianco was caught again by Burkart and on video surveillance committing these offenses. Grace was able to email me the emails and text messages that Bianco has been sending him.

These text messages were from Bianco's personal phone number (561-517-3738) which was verified by our RMS system as well. Bianco had the same phone number when he was input in RMS months prior. Bianco admits knowledge and even makes threats on the text messages that the vandalism will continue until Edward settles for his demands.

further on the text messages I observed that Bianco has graffiti multiple public places with a green marker writing NED, DACK, and their personal phone numbers around the city. There is a graffiti under the Palm Beach Lakes Bridge in green marker saying NED and DAK called the cops "heart" fuck you. Bianco then takes a picture of himself holding a green marker while riding a bike saying, "no hands".

Grace provided me with a sworn statement and advised he wanted to prosecute for the above offense. Grace stated that it would cost approximately \$2500 dollars to repaint the building and fix the electric wires.

At this time due to video evidence of Bianco willfully and maliciously placing graffiti and damaging the electric wires of a property belonging to another there is probable cause to charge Jerome Bianco with one count of CRIMINAL MISCHIEF-OVER \$1000 according to F.S.S 806.13(1B3).

Due to Bianco by Written Communication maliciously threaten Grace's reputation and property by stating that the acts of vandalism will continue with the intent to extort money there is probable cause to charge Bianco with one count of Threats; extortion according to F.S.S 836.05
