Caller advised, she witnesses a male grabbing and punching a woman outside of their vehicle in the above stated address parking lot. Department issued body worn camera was activated upon arrival.</p> <p>Upon arrival, K9 Officer Arnold made contact with both subjects inside of the vehicle located in the West parking lot by Military Trail. Officer Luciano was speaking with caller, Delene Peart (security), who was identified by her Florida driver's license (See Officer Luciano's supplement). This officer made contact with the female party involved, who was later identified as Yolanda Barber by her Florida driver's license, who was sitting in the rear driver's side of the vehicle. This officer requested Yolanda to step out of the vehicle to speak to this officer away from the male party. Yolanda stated that she and Jerry were in a verbal argument regarding his daughter coming to visit. Yolanda then exited the vehicle and started walking towards CVS to purchase items. At this time Jerry exited the vehicle and escorted her back to the vehicle. Yolanda stated that at no time did it become physical, and Jerry never struck her.</p> <p>At this time, Jerry was attempting to locate Yolanda's drivers license for this officer and both he and Yolanda began arguing back and forth. This officer ordered Jerry back inside the vehicle which he became verbally aggressive and refused to enter the vehicle until this officer walked towards him. Upon entering the vehicle, Jerry continued to become verbally aggressive. At this point, this officer could smell the odor of an unknown alcoholic beverage coming from his person which increased as he spoke. This officer requested Jerry to exit the vehicle and step to the front of it to prevent Jerry from driving and in fear of him driving off due to his aggressive mannerisms and inquire about the incident at hand. 
