at approximately 2:58 AM, at 1 AVE N/ 3RD ST N, in Pinellas County did:

WAS THEN AND THERE INTOXICATED AND CAUSED A PUBLIC DISTURBANCE, TO-WIT: DISORDERLY INTOXICATION.

THE DEFENDANT WAS HIGHLY INTOXICATED, HAD A STRONG ODOR OF ALCOHOL COMING FROM HIS PERSON, BLOODSHOT WATERY EYES. THE DEFENDANT WAS ARGUING FIGHTING WITH A CITIZEN ON THE PUBLIC SIDE WALK. 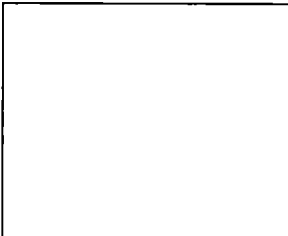
